ORDINANCE NO. 7431

AN ORDINANCE AMENDING CHAPTER 8 OF THE CODE OF ORDINANCES, REGULATING SWIMMING POOLS AND SPAS WITHIN THE CORPORATE LIMITS OF THE CITY OF MANHATTAN, KANSAS; INCORPORATING BY REFERENCE THE “INTERNATIONAL SWIMMING POOL AND SPA CODE” EDITION OF 2018, WITH CERTAIN OMISSIONS, CHANGES AND ADDITIONS THERETO; AND REPEALING ALL ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF MANHATTAN, KANSAS:

SECTION 1. That Section 8-132 of the Code of Ordinances of the City of Manhattan, Kansas, is hereby amended to read as follows:

ARTICLE XVIII SWIMMING POOL AND SPA CODE

Section 8-370. Adoption of the International Swimming Pool and Spa Code.

There is hereby incorporated by reference for the purpose of regulating all swimming pool and spa work done or performed within the corporate city limits of the City of Manhattan, Kansas that certain standard swimming pool and spa code known as the International Swimming Pool and Spa Code, 2018 Edition as recommended by the International Code Council, 500 New Jersey Avenue, NW 6th Floor, Washington, DC, 20001, save and except such articles, sections, parts, or portions thereof as are hereinafter omitted, deleted, modified or changed. No fewer than one (1) copy of such publication shall be marked or stamped “Official Copy as adopted by Ordinance No. 7431”, and shall be attached to a copy of this ordinance and filed with the city clerk and open for inspection and available to the public at all reasonable hours. All administrative departments of the city charged with enforcement of this code shall be supplied, at the cost of the city, such number of official copies, similarly marked, as may be deemed expedient.

SECTION 2. That Section 8-371 of the Code of Ordinances of the City of Manhattan, Kansas, is hereby amended to reads as follows:

Section 8-371 Amendments.

The International Swimming Pool and Spa Code, adopted by Section 8-370, is hereby changed, altered, modified and otherwise amended as follows:

1. Section 101.1 of the International Swimming Pool and Spa Code is hereby changed to read as follows:

Section 101.1 Title. These regulations shall be known as the Swimming Pool and Spa Code of Manhattan, Kansas, hereafter referred to as “this code”.

2. Section 105.6.2 of the International Swimming Pool and Spa Code is hereby deleted.
3. Section 105.6.3 of the International Swimming Pool and Spa Code is hereby deleted.
4. Section 107.4 of the International Swimming Pool and Spa Code is hereby changed to read as follows:

Section 107.4 Violation penalties. Any person who shall violate a provision of this code or shall fail to comply with any of the requirements thereof or who shall erect, install, alter or repair work in violation of the approved construction documents or directive of the code official, or of a permit or certificate issued under the provisions of this code, shall be guilty of a misdemeanor, punishable by a fine of not more than five hundred dollars (\$500) or by imprisonment not exceeding one hundred eighty days (180), or by both such fine and imprisonment. Each day that a violation continues shall be deemed a separate offense.

5. Section 108 of International Swimming Pool and Spa Code is hereby deleted.

SECTION 3. Ordinance No. 7230 and all other ordinances, or portions thereof, in conflict herewith are hereby repealed.


SECTION 4. This ordinance shall take effect and be in force from and after January 1, 2020, and its publication in the official city newspaper.

ORDINANCE NO. 7431 SUMMARY

On June 18, 2019, the City of Manhattan, Kansas adopted the following ordinance:
